A DIARY Dated: 06.05.2024

1. OP No. 102/2022 Pappanamkode Muslim Jama-ath, Thiruvananthapuram

The petitioner herein had filed this OP under Sections 32, 33, 34, 38, 47, 61, 64, 69 & 70 of the Waqf Act 1995 seeking for a direction to frame a scheme for the administration and management of Jama-ath, conduct audit of the accounts, conduct election to the management through secret ballot system, take steps against the Committee for not complying the order no. A3-3705/CR dated 8.11.2021 of Waqf Board, conduct inspection on misappropriations done by respondents 2 to 4 and take steps to recover the misappropriated amount from them, appoint Executive Officer for the management of the Waqf properties and remove the respondents 2 to 4 from Muthawalliship.

The petitioner had raised several allegations regarding the mismanagement of the Waqf and also about the intention of the committee for not complying the orders of Board, Kerala Human Rights Commission, and Hon'ble Collector so as to wreck vengeance against the petitioner. On the basis of the said petition, notices were issued to respondents to appear before the board and submit their version. However, respondents failed to appear before the Board and hence the respondents were set ex-parte. Later, the respondents filed petition to set aside Ex-parte order which was allowed on cost and the matter was posted for steps. At that time the petitioner had filed a petition to withdraw the Original Petition. On perusal of the file it is seen that one of the prayer is to conduct audit of accounts of the waqf and hence the Board cannot close this matter keeping the eyes shut. The Divisional Waqf Officer shall take necessary steps for auditing the accounts of this waqf for the period from 2019-20 to 2023-24. As the petitioner is not intending to proceed this matter further this file stands closed.

2. OP No. 10/2022 Vallakkadav Muslim Jama-ath, Thiruvananthapuram

The said O.P. is filed by the petitioners herein for getting an order to conduct election to the General Council and Managing Committee of Vallakkadavu Muslim Jama-ath for the period 2022 to 2025 through secret ballot after preparing a voters list of 5 wards of the jama-ath giving voting right to all male Muslims who attained the age of 18 years, through a Returning Officer to be appointed by the Waqf Board.

The petitioners herein are the beneficiaries of the Vallakkadavu Muslim Jama-ath. The petitioners submitted that the period of Vallakkadavu Muslim Jama-ath Committee was expired on 20/1/2022. It is also alleged that the voters list used for election from 2009 onwards prepared before 25 years back. It is further alleged that the method of election adopted by the respondents caused the continuance of their monopoly in the administration of the jama-ath and thereby resulted

mismanagement, maladministration and loss of jama-ath fund.

In the main O.P. an interim order dated 04.01.2023 was passed by the Board, appointing Adv. Manaccadu Bhadharudheen Koya as Returning Officer for conducting election. Returning Officer submitted 3 interim reports on 26.04.2023, 12.09.2023 and 28.10.2023. The Returning Officer reported that, he had initiated election process and requested concerned officers to hand over the documents of the Waqf. But the respondent, jama ath didn't ready to hand over the documents. Thereafter, as per the order of Honble Waqf Tribunal in OA No. 18/2023 dated 05.07.2023 the RO was directed to consider the grievances of the applicants regarding their eligibility of their membership in the matter of election of the Jama-ath. Hence RO prepared final voters list on 29.10.2023 after resolving all the objections, modifications and inclusions.

The Returning Officer submitted final report on 10.01.2024 and stated that he had completed election procedures peacefully. As per final voter's list there are 5291 voters in 5 wards. After that election notification was published on notice board of the jama ath on 29.10.2023 and 60 nominations received. Among 60 nominees 3 persons withdrew their nomination. Finally 57 candidates contested in the election. The election was scheduled on 03.12.2023 and the result also published on the very same day. 41 members were selected to general counsel and among them 7 members were chosen to the Jama-ath Committee.

From the report of the Returning Officer, there was no need for transfer of power or joint sitting as the former office bearers continued to be elected. There has been a very dignified co-operation from jama-ath members and petitioners to conduct the election process in a free and fair manner.

Returning Officer along with final report filed a petition to grant additional Bata. Altogether he travelled 22 days from Kollam to Trivandrum for the entire election procedure. Hence it is directed to the newly elected jamaath to grant additional batta of Rs. 40,000/-

Hence, the above O.P. file is closed with the above direction.

The petitioner had filed the O.P. praying for restraining the respondents from interfering with the administration of the 1st Petitioner committee by the 2nd Petitioner and other committee members. The respondents 1,2, and 4 appeared on 25.07.2023 and the Board directed the respondents not to take any policy decision without the prior consent of the Board. While the matter was pending before the Board the petitioner had filed this present I.A.196/2023 seeking to appoint an executive officer for the above waqf under section 38 of the Waqf Act, 1995.

The petitioner's case is that despite the Order passed by the Board, religious class is being conducted as a part of Milad shareef and collection is being done on account of construction without the approval of the Board. The Petitioner further alleged that the respondents was in habit of violating the order of the Board and thereby collecting huge amount in . different head without the approval of the Board and hence requested to appoint ,gin Executive Officer for supervising the administration and for giving necessary directions to the committee.

The respondents submitted counter denying all the allegations in the petition and submitted that there is no prayer in the main OP regarding appointment of Executive Officer. The respondents submits, that the above waqf ancient sunni waqf and only the Milad sharee program,Ratheeb, Molud and Nercha were conducted as usual in every year, receipts were given for the same and was included in the account statement also . Hence the respondent requested to dismiss the petition with cost.

In this matter Divisional Waqf Officer had passed an order directing to conduct audit of the accounts of the jama-ath for the period 2020-21 to 2021-22, but same could not be completed as the 2nd petitioner in the main D.P. who was the then secretary failed to pay the audit fee. But subsequently, the committee which was elected in the election held on 21-02-2023 had paid the audit fee. But, as the accounts for the said period is with the 2nd petitioner and the former president and even though notice was directed to them to produce the accounts for auditing they had not produced the same stating that accounts will be produced for auditing only after disposal of this case. In reply to that the Divisional Waqf Officer had informed the erstwhile president and secretary that the case before Board is not an obstruction to audit the accounts and hence, directed them to produce the documents for auditing. The 2nd petitioner herein is the secretary of the erstwhile committee.

The petitioners failed to substantiate any valid reasons for appointing an Executive Officer except some vague allegations. Also, the 2nd petitioner in the main O.P. is the erstwhile secretary who failed to submit accounts before the Board for auditing. In such circumstances, the first thing that is to be done is auditing of accounts till date and further action can he decided only after getting the audit report. The petitioner had not brought anything before this Board to conclude that it is necessary to appoint an Executive Officer for the interest of the waqf and the income limit of the waqf comes above the precondition for appointment of an Executive Officer under section 38 of the Waqf Act, 1995. Hence the IA stands dismissed.
