## A DIARY Dated: 06.11.2024

- 1. OP No. 34/2022 Kochi Thaikkav Pally, Ernakulam Order not ready. Posted to 11.12. 2024
- 2. OP No. 194/2023 Konthalappally Jama-ath, Idukky

This petition is filed under Section 32 and 69 of the Waqf Act, 1995 seeking to frame a scheme for the administration of kondalapally jamaath and for other related reliefs. Petitioners numbering 9 submitted that they are permanent residence and when fisher is konthalapalli jamaat which is a public work of and respondents to four are the office barrels of the Managing committee of the jamaat. According to the petitioners the Jama-ath established more than 100 years ago and there is another madrasa and thaikyavu Palli under kondalapalli jamaatu Palli. It was also submitted that earlier the jamaat had a vast area under it but gradually these areas where separated from the jamaat and they had established their own Jama-aths and are functioning separately. Petitioner also submitted that there are 226 Muslim families in the jamaat and the income of the jamaath is the monthly subscription from the members, rent of buildings and vessels, offerings from makbra and donations. The jamaath is not having a written bye law for the administration and there is no written covenant regarding the mutawalliship also. The petitioner submitted that the jamaath requires a proper scheme for the better administration of the waqf and hence they had approached the board for framing a scheme under section of the Waqf Act, 1995.

Notice was served to the respondents who had submitted counter stating that the Board can appropriate orders considering the absence of written by law for the Jama-ath. A third party had filed I.A. for impleading as additional respondent which was allowed by the Board and they were impleaded as supplemental respondents 5 to 7. But they failed to file counter.

As the petitioners and respondents had submitted that there is no written bye law for the Jama-ath the Board finds this as a fit case for framing a scheme for the administration of the Jama-ath under section 69 of the Waqf Act,1995. On the basis of the above finding the parties are directed to submit draft scheme from their side for the consideration of the Board within a period of 45 days from the date of receipt of this order. After receipt of the Draft Scheme the office shall submit the same before the Board through administrative side for finalization of the scheme.

- 3. OP No. 08/2024 Erumeli Mahallu Muslim Jama-ath, Kottayam Order not ready. Posted to 11.12.2024
- 4. OP No. 50/2024 South Thrithala Juma Masjid, Palakkad

The above Original Petition is filed by one Mr. Ummer under Section 32, 47 and 70 of the Waqf Act, 1995 seeking to pass order to conduct a detailed enquiry regarding the administration of South Thrithala Juma Masjid, for appointing an auditor to conduct and report the income and expenditure of the waqf from 16.12.2022 till 10.02.2024 and for other related reliefs.

The case of the petitioner is that he is a permanent resident, member, beneficiary and former committee member of South Thrithala Juma Masjid, which

is registered before the Board as 10506/RA. There are more than 410 muslim families and more than 1000 male members having voting right in the said jamaath. There is no bye law for the proper administration of the waqf. However, the administration of the waqf is vested in a committee consisting of 25 members to be elected by the General Body of the Jama-ath. For the last several years, the working committee was elected by raising hands in the General Body meeting. The petitioner had raised severe allegation regarding the last election was conducted on 16.12.2022 without issuing notice to all members of the Jama-ath. The petitioner submitted that the conduct of election was not proper and legal and the committee constituted is not a legally constituted one and the respondents are misusing and misappropriating the amount collected from Andu Nercha and Rabiul Awwal festivities without accounting the same and that the administrative committee is mismanaging the affairs of the Jama-ath. Hence, the petitioner approached the Board by filing this OP for conducting a detailed enquiry regarding the administration of the waqf, for auditing the accounts of the Jama-ath and to take stringent action against those who are responsible for the said misappropriations.

Along with the OP the petitioner had filed I.A. No.54/2024 for appointing an auditor to conduct auditing the income and expenditure of the 1<sup>st</sup> respondent waqf from 16.12.2022 to 10.02.2024. The above IA was considered by the Board and passed an order on 14.02.2024 by directing the Divisional Waqf Officer, Thrissur to conduct audit of accounts for the years 2022-2023 to 2023-2024 and to complete the procedure as per the powers delegated to him.

The Board had issued notices to the respondents to appear before the Board. Even though the respondents 1 to 4 appeared before the Board through their counsel no counter was filed by them. On 11.09.2024, the Board heard the parties and matter was posted for orders.

As one of the main prayer in the above OP, auditing the accounts of the Jama-ath is already allowed by the Board by directing the Divisional Waqf Officer, Thrissur to conduct auditing of accounts of the Jama-ath, he is further directed to

complete the audit process, call for explanation and correction of defects pointed out in the audit report and if any amount is to be recovered from any person on the basis of audit report the Divisional Waqf Officer shall place the matter before the Board through administrative side. The Divisional Waqf Officer, Thrissur shall conduct an overall enquiry with regard to the administration of the waqf involved in this matter covering all the allegations in the petition and shall take further action if found necessary invoking the powers delegated to him. If any decision of the Board is needed for taking further action he shall place the matter before the Board through administrative side.

# 5. OP No. 14/2024 Kuzhikkattumoola Mahallu Muslim Jama-ath, Ernakulam

The main OP is filed by the petitioner seeking to conduct election to the managing committee of the Kuzhikkattumoola Muslim Jama ath. The petitioner alleges that the 2<sup>nd</sup> respondent interim mutawalli is managing the affairs of the waqf on a remuneration basis and because of the absence of the elected committee for the administration of the waqf , the jama ath members do not have opportunity to discuss the day to day affairs of the waqf and that the interim mutawalli is not able to collect subscription from the members of the jama ath thereby to increase the income of the jama ath . Hence, the petitioner sought for the conducting election to the managing committee of the jama ath in accordance with the bye-law.

During the pendency of the O.P, IA No: 191/24 was filed before the Board seeking to implead them in this proceedings as they are members of the Jama-ath. Any person who is interested in the affairs of the Jama-ath can be impleaded in proceedings with regard to the administration of the Jama-ath. In order to avoid multiplicity of proceedings and for carrying out a fair adjudication it is proper to implead the petitioner in this proceedings as a beneficiary of the waqf. In such circumstances the Board hereby allows the

I.A. and the petitioners are impleaded as additional respondents. Office is directed to carryout amendment on the basis of this order.

#### 6. OP No. 64/2024 Hyderiyya Masjid Mahallu Committee, Palakkad

The above original petition has been filed by the petitioner under sections 32, 70 and 71 of the Waqf Act, 1995 seeking to appoint a returning officer to conduct an election through secret ballot paper in the 1<sup>st</sup> respondent Waqf, to restrain the conduct of election to the 1<sup>st</sup> respondent Waqf without prior permission of the Board, to audit the income and expenditure accounts of the 1<sup>st</sup> respondent Waqf for the period 2015-2023 and for other related reliefs.

While the said matter was pending before the Board the petitioner herein had filed the present I.A. seeking to implead him as additional 3<sup>rd</sup> respondent in the OP. The petitioner claimed that he is the mutawalli of the 1<sup>st</sup> respondent waqf and the petitioner had suppressed this fact from the Board and hence prayed to implead him as additional respondent no.3

The petitioner submitted objection stating that for the past 3 decades the waqf is managed by a managing committee and not by mutawalli as claimed by the petitioner and also alleged that the petitioner is functioning as treasurer of the 1<sup>st</sup> respondent and hence requested the Board to dismiss the petition as petitioner is not having locus standi to file this application.

The Board discussed the matter in detail after bearing both the parties. The claim as to whether the petitioner is the mutawalli or not is a matter of evidence which is to be proved and hence he cannot be impleaded as the mutawalli of the waqf. But it is clear that he is beneficiary of the waqf as the petitioner in the main OP is not having a case that he is not a member of the Jama-ath. On the other hand the petitioner in his counter stated that the petitioner is a part of managing committee. In order to avoid multiplicity of proceedings and for carrying out a fair adjudication it is proper to implead the petitioner in this proceedings as a beneficiary of the waqf. In the connected matter which is filed as OP No.60/2024 the petitioner herein is impleaded as additional respondent on the basis of petition filed by him. On the basis of the above findings the I.A. stands allowed. The petitioner is impleaded as Additional 3<sup>rd</sup> respondent and the office is directed to carryout amendment in the basis of the impleadment.

- 7. EP No. (A3) 3338 & 3339/CR Haji Essa Haji Moosa Sait Trust and Jan Muhammed Essa Sait Trust, Ernakulam Order not ready. Posted to 11.12.2024
- 8. OP No. 116/2022 Konthalappally Juma Masjid, Idukky

This O.P. is filed by the petitioners seeking to conduct audit of accounts of the jama-ath, election to the jama-ath committee by appointing a returning officer and for other related reliefs. While the petition was pending before the Board I.A.206/2023 was filed by the petitioners seeking direction to the respondent jama-ath committee to accept the original demand drafts

produced by the petitioner and issue receipts after encashing demand drafts. The said I.A was allowed and the office was directed to forward the demand drafts attached with the petition to the jama-ath committee with a direction to accept the same and submit receipt before the Board. In compliance with the direction of the Board the office had forwarded the demand draft to the waqf. The jama-ath committee had submitted a letter dated 30-04-2024 along with a receipt with regard to the 13 cheques forwarded from this office and submitted that the date of the cheques were 09-10-2023 and its validity is 3 months and hence same could not be presented before bank for honoring. seems The reason stated by the committee was that the period of the demand draft was over. Subsequently, the petitioner had paid full subscription to the counsel for the respondent on 07-08-2024. As the counsel for the jama-ath committee had accepted the money in the sitting of the Board and Board had recorded the same it can be seen as a valid receipt for the money.

The prayer to conduct audit is already allowed by the Board and hence, Divisional Waqf Officer, Kottayam is directed to complete the procedures in connection with audit after receipt of the audit report and if any amount is to be recovered from any person on the basis of certification of the auditor he shall place the matter before the Board through administrative side. While this matter was pending before the Board

### 9. OP No. 212/2023 Anwar Masjid, Thrissur

The petition is filed seeking to restrain the respondents and their men from interfering the peaceful possession and enjoyment of the Waqf property and for other related reliefs. An interim order is already passed by the Board restraining the respondents as prayed in the I.A. Eventhough the respondent appeared, they failed to submit counter and on 07/08/2024 the counsel for the petitioner submitted no instructions. It is seen that the petitioner is not

intending to prosecute the matter further and hence the OP stands dismissed.

#### 10. OP No. 252/2023 Meppara Jama-ath Mosque, Palakkad

The petitioner had approached the Board by filing this prosecution petition under section 61 of the Waqf Act,1995 against the interim mutawalli appoint by the Board for Meppara Muslim JAma-ath for violation of the order passed by the Board. The Board had passed an order in OP 146/2022 directing the interim mutawalli to accept the monthly subscription from the petitioner if he is having all other qualifications to become a member of the Jama-ath. The petitioner submitted that when he approached the respondent for membership as per the order of the Board the interim mutawalli told him that the order of the Board will not help the petitioner to get membership in the JAma-ath. Hence the petitioner had filed this prosecution petition.

Notice was issued to the interim Muthawalli and on 24/04/2024 Adv.Peer Mohammed Khan Offered Vakalath but after that there was no representation for the respondent. Hence the matter was posted for orders. On perusal of the file the Board feels that a notice is to be issued to the Interim Mutawalli for direct appearance before the Board before taking further action considering the facts that he is a practicing lawyer and is appointed by the Board as Interim Mutawalli. In such circumstances the Interim Mutawalli is directed to appear directly before the Board in its meeting to be held at Ernakulam on 11/12/2024 at 11AM with his explanation regarding the allegations in the petition.

# 11. EP No. 4270/2023 Munavvirul Islam Mahallu Committee, Palakkad

This enquiry proceedings was initiated on the basis of a complaint submitted by smile pk with regard to reinstation of his Mahal membership.

According to the first party/ petitioner the Mahal committee had caused obstruction in the marriage of his son and had declared non- cooperation with the family on the basis of the same. On the basis of the complaint an enquiry was conducted by deputing an officer of the board who had reported that on the basis of the explanation received from the waqf secretary it is seen that a transfer certificate was issued to the 1st party on the basis of application submitted by the first party/ petitioner and subsequently the first party they had informed the committee about his wish to get his membership reinstated. The Jama-ath committee had informed him that the said action could be completed only after getting sanction from the General Body. On the basis of the enquiry report the Divisional Waqf Officer had conducted hearing but the matter could not be resolved. Hence matter was placed before the Board. The Board had conducted a mediation talk and in which the Jamaath committee informed that membership can be provided if the petitioner/1st party apply for the same along with his pardon for his actions against the committee. The 1st party petitioner had submitted an application on the basis of mediation in which he expressed his pardon for the words he had spoken against the committee and assured that he will not repeat such activities in future.

As the 1<sup>st</sup> party had complied with the decision in the mediation the 2<sup>nd</sup> party Jama-ath shall issue membership to the 1<sup>st</sup> party within 15 days. He shall be provided with all rights and privileges as a member of the Jama-ath and the 1<sup>st</sup> party shall pay requisite membership fee to the Jama-ath equal to the amount paid by other members. Both the parties shall co-operate with each other and shall not do any activity which destroys the peace and unity of the Jama-ath.

12. OP No. 128/2024 Thottathumpady Muslim Jama-ath, Ernakulam As marriage certificate is issued to the petitioner the Board finds

that this matter need not be proceed further. Hence OP is closed.

13. OP No. 40/2014 Mulavoor Central Mahallu Jama-ath, Ernakulam Order not ready. Posted to 11.12.2024

### 14. OP No. 218/2023 Muhiyudheen Juma Masjid, Ernakulam

The main OP is filed by the petitioners under section 32 of theWaqf Act, 1995 and Rule 75 of the Waqf Rules seeking to declare that the management and administration of 1st respondent jama-ath is to be carried on as per the stipulations and guidelines in the Exhibit P2 deed (Deed No. 560/1938), further declare that the kaikars and muthavally from among them are entitled to continue in affairs, administration and management of the jama-ath, to declare that the 'Muhiyudheen Juma Masjid Jama-ath Committee ' under the leadership of the respondents 3 and 4 has no locus standi, right or authority to interfere in the affairs and administration of the 1st respondent jama-ath, to prohibit the respondents 3 and 4 and their committee from interfering in the management and administration of the 1st respondent jama-ath, to declare that decisions and actions if any taken by respondents 3 and 4 are in no way affecting the 1st respondent jama-ath and its members and to pass other related reliefs.

On 17.10.2023 petitioners had filed I.A 197/2023 seeking order for appointing interim muthavalli in the 1<sup>st</sup> respondent jama-ath for carry out the day to day affairs of the jama-ath for the time being. On 28.02.2024 respondents nos 3 and 4 had filed counter to the I.A. They submitted that petitioners have not raised any contentions or ingredients attracting section 63 of the Waqf Act to appoint an interim muthavalli and the I.A is not sustainable and moreover this Board as per Order in I.A No. 83/2023 in OP No. 94/2023 restrained from conducting

election without prior consent from the Board. They had also filed argument notes regarding the matter. On the same day petitioners had filed I.A No. 198/2023 seeking to pass an interim order prohibiting the respondents 3 & 4 from interfering in the affairs of 1<sup>st</sup> respondent jamaath during the pendency of the main OP.

As this is a matter of mutawalli dispute the Board finds that the prayers in both the I.A.s can be decided only after taking evidence with regard to the rights of both parties to administer the waqf and as to who is eligible to administer the waqf. Hence Board decides to consider both the above I.As. along with the main OP.

- 15. EP No. (A3) 3300/CR Abdul Sathar Haji Moosa Sait Dharmastapanam, Ernakulam
  - This is an enquiry conducted on the basis of request submitted by 2<sup>nd</sup> party for appointing her as trustee of the Waqf. At present the administrative of the trust is taken over by the Board under section 65 of the Waqf Act for a period of 2 years on the basis of order dated 03.07.2024. Hence at present there is no need to consider this matter regarding appointment of trustee. This request can be considered at the time of appointment of Trustee when term of administration of Board is over.
- 16. OP No. 06/2024 Puthoor Pally Muslim Jama-ath, Kottayam Razi filed as per settlement arrived on mediation. Hence OP stands closed. Razi shall form part of this order.
- 17. OP No. 108/2017 Chuloor Muslim Jama-ath, Thrissur

The main O.P. is filed by the petitioner seeking to audit the accounts of the waqf conducting enquiries into the construction and financial dealings of the respondent and also to take actions against the responsible persons if any irregularities are found by the Board. The petitioner had raised several allegations with regard to the

accounts and financial dealings in the waqf. The respondents appeared and filed counter strongly opposing the allegations and submitted that there is bye-law for the administration of the jama-ath and the committee is acting as per the bye-law and the details of the accounts are prepared and presented regularly before the general body, that the construction work are carried out by the construction committee and all details are available in the jama-ath and that election to the jama-ath committee is held as per the decision of general body in a transparent manner.

The Board had ordered auditing of accounts for 3 years from the year 2014 and audit report was submitted initially stating that the accounts of the construction works were not presented before the auditor for audit. Subsequently, vide an order dated 19-08-2020 the Board had directed the auditor to complete the auditing and accordingly the audit was completed by the auditor. After completion of audit the auditor had submitted his report and it is seen that except some minor discrepancies in keeping and finalizing the accounts which is the result of lack of knowledge in scientifically maintaining accounts there is no serious defects are pointed out the management and administration of the waqf. It is seen that the auditor had not certified any amount as per section 47 of the Waqf Act for recouping from any person. In the absence of such a certification no further action of recovery from any person is warranted. In such circumstances, the action to be taken is

correction of mistakes in keeping and finalizing accounts by the jama-ath committee which can be done by the Jama-ath Committee in consultation with the office of the Board and the Committee should ensure that the mistakes in keeping accounts are not repeated. The petitioner failed to produce any document to prove his allegations and in his evidence it is admitted that he has only hearsay evidence on the allegations. In such circumstances the Board finds that the OP deserves to be dismissed.

### 18. OP No. 236/2023 Vazhoor Muslim Jama-ath, Kottayam

The petition filed by petitioners stating that they are are residing within the boundary of Vazhoor Muslim Jama-ath, for years and they are not given membership of the Waqf having voting right hence they are not able to participate in the management of the Waqf. The petitioners case is that they are willing to take the membership of Vazhoor Muslim Jama-ath but as they are not permitted by the Jama-ath they had approached the Board by filing this petition.

The contention of the respondents are that membership is given on the basis of written byelaw and the committee can function only in accordance with the provision in the byelaw accepted and approved by the general body. Merely by the reason that a person was a resident for years or that he is Muslim and that though he is from another jama-ath and he obtained NOC from the said jama-ath to join in the respondent jama-ath didn't have any right to become the member of the respondent jama-ath as per the bye law of the Jama-ath and any changes in the provisions of byelaw can be effected only by the general body unless the clauses in the byelaw are declared as unconstitutional. Only such persons whose names are included in the

Vazhoor Muslim Jama-ath membership register alone are having the voting right and become member of the governing committee. The Jama-ath Committee further submitted that any person residing within the jurisdiction of the Jama-ath are provided with all services like issuing necessary documents, burial facility without any discrimination etc. They are not denying any rights except the right to participate in the general body, vote and becoming a member of the Jama-ath.

On perusal of the file it is seen that the Jama-ath is having a bye law and as per the bye law only such persons whose names are included in the Vazhoor Muslim Jama-ath membership register alone are having the voting right and become member of the governing committee. The respondent committee had agreed that they shall provide all facilities to the petitioners for which they are eligible as a muslim like issuing necessary documents, burial facility without any discrimination etc. In such circumstances the Board directs the Jama-ath committee to provide a basic membership to the petitioners by which they are provided with all religious services that are provided to a member of the Jama-ath except the voting right and right for administration as mentioned in the bye law. The Jama-ath committee can collect a monthly subscription for such membership and with regard to the membership which provides voting right and election to governing body the petitioners shall be heard by the Jama-ath committee and shall take a decision empathetically. The petitioners shall co-operate with the Jama-ath and shall not do any activity which destroys the unity and integrity of the Jama-ath. The JAma-ath Committee shall not deny any religious rights that are provided to the members of the JAma-ath to the petitioners. Matter is disposed of accordingly.

19. OP No. 62/2022 Amayoor Juma Masjid, Palakkad Order not ready. Posted to 11.12.2024

- 20. OP No. 122/2023 Kuttilanji Methala Muhiyudheen Juma Masjid , Ernakulam Order not ready. Posted to 11.12.2024
- 21. OP No. 110/2023 Kilikolloor Valiya Pally Jama-ath, Kollam

This O.P. is filed by the petitioners who are members and beneficiaries of the 1<sup>st</sup> respondent jama-ath had approached the Board by filing this petition against the office bearers of Kilikolloor Valiya Palli Muslim Jama-ath, Kollam seeking to direct the 4<sup>th</sup> respondent returning officer to prepare draft voters list either as per the voters list on the basis of bye-law and jama-ath register or to publish the voters list published in the year 2018 as draft voters list and invite objection and prepare final voters list for conducting election, and for other related reliefs.

The petitioners had produced 5 documents along with the original petition. Document No.1 is the bye-law of the jama-ath, document No.2 is the notice published by the returning officer, document No.3 is the registered lawyer notice of the petitioners, document No.4 is the draft voters list and document No.5 is the census form. On the basis of the petition notices were issued to the respondent to appear before the Board and submit their version. Even though respondent No.4 is the returning officer appointed from the Board he is failed to appear before the Board and submit report with regard to the actions taken by him. In such circumstances, the Board decides to pass the following orders:

- a) The Divisional Waqf Officer, Thiruvananthapuram is directed to conduct an over all enquiry with regard to the administration, election and accounts of the jama-ath and conduct audit of accounts from the period 2019 to 2024.
- b) The returning officer shall submit before the Divisional Waqf Officer draft voters list and show cause as to why he failed to

- submit report before the Board within a period of one week from the date of receipt of this order. The Divisional Waqf Officer shall submit his report before the Board on 16-12-2024.
- c) After the conduct of audit the Divisional Waqf Officer shall call for explanation with regard to findings if any in the audit report and shall take steps to ensure curing of defects in maintaining accounts if any pointed out by the auditor. If the auditor certifies that recovery of money from any person is to be done the matter shall be placed before the Board through administrative side for passing orders.
