Posted to 19.02.2025 IA No. 3/2025  The above OP is filed by one Mr. Abdul Shukkoor & others seeking an order to set aside the decisions taken in the extra ordinary general body of Kumarapuram Muslim Jama-ath dated 03.12.2023 stating all the decisions taken are illegal, to set aside the decision taken on 14.09.2023 by removing the 1 <sup>st</sup> petitioner from the post of President stating that there is no quorum as stated in byelaw, to reinstate the post of president of the 1 <sup>st</sup> petitioner and membership of the petitioners in the paripalana samithi, for restraining the respondents 10 to 13 from working as the members of paripalana samithi and for other related reliefs.  The above I.A. is filed by the petitioners seeking to stay the decision of the paripalana samithi dated 14.09.2023 removing the 1 <sup>st</sup> petitioner from the post of President and the decision alleged to be taken by the extra ordinary General Body dated 03.12.2023 removing the petitioners and another committee member namely Ahammed from the paripalana samithi and including respondents 10 to 13 in the paripalana samithi till the disposal of the Original Petition.  Heard the counsel appearing for the petitioners and perused

the documents submitted before the Board. The Petitioners are challenging the decisions of the General Body of the 1<sup>st</sup> Respondent Jama-ath held on 03.12.2023 by which 4 members were removed from the Jama-ath committee and another 4 members were elected in their place. The removal of the 1<sup>st</sup> Petitioner from the post of the President by the managing committee dated 14.09.2023 held without required quorum also is under challenge. The report of the Waqf Inspector who attended the meeting as an observer is produced along with the O.P. The report and the notice appended to the same shows that the said General Body was an extra ordinary meeting held for the discussion of a resolution submitted by the Jama-ath members. As per the notice of the meeting, removal and election of committee members were not in the agenda. As per clause 23(D2) of the byelaw of the 1<sup>st</sup> respondent Jama-ath election to the managing committee can be made only in the annual general body meeting. Report of the observer further shows that before taking the resolution for removal of petitioners for discussion a pandemonium was created in the meeting, Police interfered and directed the Chair to wind up the meeting and the attendees to go out the meeting hall. All these prima facie shows that the disputed decisions were not taken in a proper way. The copy of the letter of the Divisional Waqf Officer dated 28.11.2023 produced along with the O.P. shows that the Respondents were intimated about the pendency of the O.P. 216/2023 before the Board challenging the removal of the 1<sup>st</sup> Petitioner from the post of the President and it is directed that taking any decisions changing the present structure of the committee by removal or co-option shall be subject to the decisions of the Board.

The Petitioners have made out a prima facie case and the balance of convenience also is in their favour. Hence the decisions of the managing committee of the 1<sup>st</sup> Respondent dated 14.09.2023 removing the 1<sup>st</sup> Petitioner from the post of the President and also the decision of the extra ordinary general body meeting dated 03.12.2023 removing the Petitioners from the managing committee and electing the Respondents 10 to 13 to the committee are stayed until further orders.
