The petitioners had filed the main O.P. under section 32, 45, 70 and 71 of the Waqf Act, 1995 seeking to audit the accounts of the jama-ath for the period 2014 — 2024 and to take action against responsible persons if it is found that waqf fund is illegally utilized or lost, to appoint a returning officer for conducting election to the jama-ath committee and for other related reliefs.

I.A.No. 309/2024 is filed seeking to direct the respondents not to take policy decisions and not to carry out any constructions without the prior permission of the Board until a new committee is elected through a Returning Officer appointed by the Board. Eventhough notice was served on the respondents they failed to appear before the Board. From the averments of the petitioner it is clear that the term of the committee expired and hence the Board finds that it is proper to allow the I.A. as prayed for. The respondents are hereby directed not to take any policy decisions with regard to the administration of the waqf except carrying out day to day administration of the waqf and not to carryout any constructions in the waqf premises.

IA No. 310/2024

The petitioners had filed the main O.P. under section 32, 45, 70 and 71 of the Waqf Act, 1995 seeking to audit the accounts of the jama-ath for the period 2014 — 2024 and to take action against responsible persons if it is found that waqf fund is illegally utilized or lost, to appoint a returning officer for conducting election to the jama-ath committee and for other related reliefs.

I.A.No. 310/2024 is filed seeking to appoint a suitable person as the Returning Officer for conducting election to the Jama-ath.

According to the petitioner the last election to the Jama-ath Committee occurred in the year 2014 and the term of the said committee expired in the year 2016. Hence the petitioner had approached the Board. Eventhough notice for hearing was issued to the respondents they failed to file counter and it is to be reasonably presumed that they have nothing to submit in this

matter. As it is seen that the term of the committee is expired long back the Board is of the opinion that it is proper to appoint a Returning Officer for conducting election to the Jama-ath Committee through Secret Ballot system. On the basis of the above finding Adv. Kaniyapuram Haleem is appointed as Returning Officer for conducting election to the Jama-ath Committee through secret ballot system as per the provisions of the Bye law of the JAma-ath. He shall conduct election after following all procedural formalities and shall complete the process within a period of 3 months from the date of receipt of this order. The Returning Officer shall be entitled for an initial batta of Rs.25,000which shall be paid by the Jama-ath Committee. The expenses for conducting election shall be met from the Jama-ath funds. The Returning Officer can receive an amount not greater than Rs.2500/- as Nomination fee from the candidates. He shall complete the election process and submit report before the Board. Posted to 19/02/2025 for interim report of Returning Officer.

Board had conducted a mediation talk between the parties and the matter was settled on the basis of Razi signed by both the parties. The following direction are given on the basis of razi and for the better functioning of the mahal.

- 1) The action of the jama-ath committee in suspending the petitioners Shahul Hameed and Kaja Hussain for a period of 6 months is cancelled by the jama-ath. The petitioners shall pay the entire due in subscription to the mahallu after deducting the advance amount of 4 months and 3 months respectively. An amount of Rs.390/- @ Rs.65 per month for a period of 6 months is due from Shahul Hameed and Rs.455/- @ 65 per month for 7 months is due from Kaja Hussain. The membership of the petitioners will be reinstated up on payment of the above amount.
- 2) The mahallu committee shall issue receipt for the payment of above monthly subscription.
- 3) Up on payment of the amount due towards monthly subscription the membership of the petitioners will continue without any hindrance and shall receive all services from the mahal as a member of the mahal.
- 4) The petitioners shall not cause any unauthorized obstruction in the land of the jama-ath using any object.
- 5) The 1st and 2nd party/petitioners shall withdraw all the statements in the letter given to the mosque with regard to the burial of the dead bodies of themselves as well as their family members.
- 6) The petitioners shall withdraw all connected cases with regard to the very same subject matter filed before other forums in the light of the compromise entered.
- 7) The petitioners shall not defame the mahal and shall not make any

unnecessary comments against the mahal jama-ath and its committee through social media platform.

Matter is closed accordingly.

66. EP No. A9- 7212/2024 Palathulli Muslim Jama-ath, Palakkad Counsel filed a statement. Order passed vide separate sheet.

A complaint was received in the office of the Board stating that party No.2 and 10 others were expelled from the membership of Palathulli Juma Masjid waqf which is waqf registered with the Board as 10366/RA. According to the petitioners they were denied of their rights as a member alleging that they had submitted a complaint before the Board on 30-05-2024 against the administration carried out by the jama-ath committee. When the matter came before the board on the counsel for the jama-ath committee submitted a statement before the board that the petitioners are having equal rights in the Palathulli Muhiyudheen Juma Masjid which is applicable to all mahal members in the said juma masjid. He had also produced a notice of the committee withdrawing the decision of the committee dated 18-06-2024 expelling 10 persons from the mahal. In the said notice the committee had expressed their regret with regard to the above action. On the basis of the said statement the following order is passed.

- 1)The action of the jama-ath committee in expelling the petitioner and 10 others is cancelled as submitted by the jama-ath committee in its statement.
- 2)The petitioners shall pay the entire due in monthly subscription to the mahallu committee immediately. The membership of the petitioners will be reinstated up on payment of the above amount.
- 3)The mahallu committee shall issue receipt for the payment of above monthly subscription.
- 4)Up on payment of the amount due towards monthly subscription the membership of the petitioners will continue without any hindrance and shall receive all services from the mahal as a member of the mahal.
- 5) The petitioners shall cooperate with the mahallu committee and shall not cause any problem in the mahal which destroys the unity and peace in the jama-ath.
- 6)The petitioners shall withdraw all connected cases with regard to the very same subject matter if any filed before other forums.
- 7)The petitioners shall not defame the mahal and shall not make any unnecessary comments against the mahal jama-ath and its committee through social media platform and mahallu committee shall not impose unreasonable disciplinary action against its members.
