According to the petitioners, the Board had already initiated prosecution proceedings against the respondents as they are reluctant in complying with the directions issued from the Board. The main O.P. was filed by the petitioners seeking to audit the accounts of the 1<sup>st</sup> respondent waqf from the period 2016 to till date, for realizing the misappropriated amount from the respondents 2 to 4 and for taking punitive action against the respondents and for other related reliefs.</p> <p>The respondents filed counter in the I.A. stating the Board has no authority to remove from their offices unless and until the Board and Criminal Court finds that the respondents are guilty of the offences alleged against them and that WOA 68/2022 filed before the Waqf Tribunal, Kozhikode by them against the order of the Board in I.A. 90/2018 is still pending before the Waqf Tribunal.</p> <p>On perusal of the file relating to this matter it is seen that prosecution case and appeal against the order of the Board is pending consideration by Courts. In such a situation this petition is premature and cannot be considered now and hence the Board decided to consider this I.A. along with the main OP after conducting a full fledged trial.</p> |

expulsion from the membership of the Jama-ath and non-compliance of the lawful orders of the Divisional Waqf Officer, Thiruvananthapuram, to restore the membership of the petitioner and for other ancillary reliefs. Petitioner claimed that he was the beneficiary and ex secretary of the above jama-ath committee.

The petitioner had filed an IA 111/2024 against the respondents for initiating prosecution for the non-compliance of the order of the Board in IA No. 270/2023 in OP No. 248/2023 “restraining the respondents from denying any service to the petitioner as a member of the Mahal”. The petitioner submitted that earlier 6 orders were passed by Divisional Officer, Thiruvananthapuram right from 20/12/2022 directing the respondents to extent all services within 10 days. Thereafter on 8.02.2023, 06.03.2023, 24.05.2023 and 22.09.2023 orders were passed by the Divisional Officer, Thiruvananthapuram against the respondents. Lastly on 04.08.2023 Divisional Officer, Thiruvananthapuram passed orders to extent services to the petitioner’s daughter marriage. Though the marriage was conducted but the marriage certificate was not issued in spite of registered request.

The respondent had filed objection against the Interlocutory Application stating that the petitioner is not a trustworthy person. He had fabricated letter head of Kerala State Waqf Board, and made a notice dated 10.11.2014 against the respondents pretending to issued by the Waqf board. Ex-parte order in IA 270/2023 was obtained fraudulently. The respondent committee never suspended the petitioner from mahel. The respondents never denied any services to the petitioner’s daughter marriage. The petitioner had not so far turned to receive the marriage certificate of his daughter.

On perusal of the file it is clear that the Jama-ath Committee had conducted marriage ceremony of the daughter of the petitioner. For obtaining a certificate with regard to that the parties should file a request for issuance of the same and should collect the same from the Jama-ath. In this matter the Jama-ath submitted that they are not having any objection in issuing the certificate. The petitioner is directed to approach the committee for collecting the Marriage certificate. If the petitioner approaches the committee and all the applications are submitted properly and requisite fee is remitted the committee should issue the certificate which shall be collected by the petitioner. The petitioner shall be provided with all services from the
