- 3. EP No. A9-5889/24/TVM Karuva Muslim Jama-ath, Kollam The Committee appeared and sought pardon for the past incidents and agreed to obey directions from Board. Auditing of accounts of the Jama-ath is already ordered by the Divisional Waqf Officer, Thiruvananthapuram. The Divisional Waqf Officer, Thiruvananthapuram shall complete the audit process and shall call for explanations if necessary and shall further give directions for correcting the mistakes in keeping amounts as pointed out by the auditor.

As the term of the committee is over and election is necessary, Adv. Nazeer Hussain, Kollam is appointed as the Returning officer for counducting election through secret ballot system as per the bye law of the Jama-ath. An initial batta of Rs. 25000/- shall be paid by the Jama-ath committee to the Returning officer within 15 days of receipt of this order. The Returning officer shall complete election process within 3 months and expences of the same shall be met from the Jama-ath funds. The Divisional Waqf officer, Thiruvananthapuram shall depute 2 officers as observers for the andunercha scheduled on 13th and 14th December. Posted to 16.12.2024

4. OP No. 216/2023 Kumarapuram Muslim Jama-ath, Thiruvananthapuram

The petitioner had filed the O.P. praying for declaring that the committee meeting held on 14.09.2023 claimed by the respondents Nos.2 to9 was not a quorum meeting as per the bye law and to quash the decisions taken on that meeting as illegal and against the byelaw and also restraining the respondents from interfering with the administration of

the 1strespondent committee by the Petitioner as the President of the Jamaath. Along with the OP the petitioner had filed this present I.A.191/2023 praying for restraining the respondents from interfering with the administration of the 1st respondent committee by the Petitioner as the President of the Jamaath

The petitioner's case is that, when the election was not conducted even after the expiry of the term, one of the member of the committee filed OP.130/2022 before the Board and some members of the committee challenging the Order passed in the above OP before the High Court of Kerala as OP(WAKF)31/2022 and election to the committee were held on 19.02.2023 by two Advocate commissioner appointed in the above OP(WAKF)31/2022. The petitioner and respondents are the members of the committee so elected. The petitioner is the President of the committee elected on 19.02.2023. According to the clause 11(b) of the bye law of the Jamaath the committee meeting are held on second Saturday of every month and as per clause 11(d) the quorum of the committee meeting is eight person including the president and vice president. Accordingly the second respondent has given notice of the committee meeting to be held on 14.09.2023. All members are attended except Vice president and joint secretary and the petitioner proposed to move the meeting to another day. The petitioner and four members left the place due to lack of quoarom. In the above meeting a motion of no confidence was presented and passed against the petitioner as the president of the above committee and Abdul Jabbar, the 9th respondent herein was elected as the president of the committee. As per clause 17(d) of the bye law the power to present and approve a motion of no

confidence against the person elected by the people is vested only with the General body of the Jamaath.

The respondents submitted counter denying all the allegations in the petition and submitted that from the beginning itself the petitioner acted in dictatorial style in taking unilateral decision without consulting other members of the executive committee. On 14.09.2023 eight members of the executive committee have submitted non confidence motion against the petitioner. In the non confidence resolution it is alleged that the petitioner failed as a president to maintain the joint responsibility and has no discipline and has no persuasive skills for conciliation. He used to disrespect and to belittle other members of executive committee. He did not permit the secretary to write the minutes. On 12.08.2023 in the committee meeting the petitioner prepared the minutes granting the jamaath member ship to his two married daughters who have been residing along with their family outside the jamaath. The membership matter of his two daughters was not at all discussed and decided in the meeting on 12.08.2023. The action of the petitioner in granting membership to his daughters was done without informing the members of the jamaath and the same decision was also against the bylaw of the jamaath. The petitioner is granting leave to the staff in the jamaath unilaterally without informing the secretary and the action of the petitioner have affected the income of the jamaath. The petitioner willfully abstained from the meeting on 09.09.2023 and demanded the 2nd respondent to adjourned the meeting with a malafide intention to disrupt the celebration of the Milad sheriff. The executive committee convened on 14.09.2023 discussed the non confidence resolution and the majority of the members supported the resolution and accordingly removed the petitioner from the position of the president, the entire meeting was conducted in the presence of the petitioner and the same was presided by him. In the same meeting itself the 9th respondent was elected as new president of the jamaath.

The petitioner had produced the Bye law of the Jama-ath as Document no.1 and the respondent had not raised any objection regarding the byelaw produced by the petitioner and it is to to be considered that the said document is admitted by both the parties. As per the bye law the procedure for removal of Executive Members including the President is contemplated in Clause 17(d) which reads as "എതൊരു ഭരണസമിതി അംഗത്തെയും പൊതുയോഗത്തിൽ അവിശ്വാസപ്രേമേയം കൊണ്ടുവന്ന് ഭൂരിപക്ഷാനുകൂല്യത്തോടെ മാറ്റാവുന്നതാണ്" . From that it is clear that the removal of the President except for the reason of continuous absence in 3 consecutive meetings shall be done only by the General body. So the decision dated 14.09.2023 expelling the President by the Executive Committee is against the provisions of the Bye Law of the Jama-ath. The petitioner had produced document no.4 that is a proclamation dated 04/12/2023 indicating that the General Body dated 03/12/2023 have resolved to pass non confidence resolution to remove petitioner and 3 others. The notice of the General Body meeting is produced as document no.2 and the notice does not disclose any specific subject pertaining to the non-confidence motion against the President in the agenda. It is also found that in the notice calling for the General Body meeting 9th

respondent is shown as the President and not the Petitioner who was not removed by the General Body. The General Body which was held on 03/12/2023 ought to have been presided by the petitioner and only after the removal of the President by the General Body the other person who is elected by the General Body would come into picture and hence it is clear that the removal of the president by the Executive Committee is against the bye law of the Jama-ath and as a result the General Body called for by the 9th respondent is procedurally irregular. Hence the Board finds that the I.A. is to be allowed and the respondents are restrained from causing obstruction to the petitioner in functioning as the President of the Jama-ath. The main O.P is filed by the petitioners under section 32,69 and 70 of the Waqf Act,1995 seeking to issue appropriate order/direction appointing a receiver to take over the administration of the 1st respondent jama-ath and to conduct free and fair election in accordance with the bye-law of the jama-ath within a time frame fixed by the board.

Respondents appeared and filed objection to the O.P. They stated that the present paripalana samithi is strictly following the bye-law of the mahal. They submitted that the petitioners are very well aware about the

terms of the present parapalana samithi and the above experimental petition is filed only to harass the respondents. They argued that there is no question of appointment of receiver arises because present paripalana samithi convened a general body meeting on 10.04.2024 and declared general election on 2nd June 2024 subject to the approval of the waqf Board in the above case until then the present paripalana samithi has right to continue. They prayed for dismissal of the O.P.

Respondents in the main O.P had filed I.A No. 115/2023 seeking permission to conduct election on 02.06.2024 or any other date fixed by the Board.

It is admitted that the term of the committee is over and they had taken steps for conducting election through a returning officer appointed by them. In such circumstances the Board finds this as a fit case for appointing Returning Officer for conducting election to the Jama-ath committee through a Returning Officer appointed by the Board. Hence Adv.M.Ziad, Kollam is appointed as Returning Officer for conducting election to the Jama-ath Palli involved in this matter as per the provisions of the bye law of the JAma-ath. The Returning Officer shall conduct the election after following all legal procedures for publishing voters list, nominations, procedure for election etc. The Returning Officer shall be entitled for an initial batta of Rs.25,000/- which shall be paid by the JAma-ath Committee within 15 days from the date of receipt of this order. The expenses for conducting election shall be met from the JAma-ath funds. The Returning Officer shall complete the election process within a period of 3 months and submit report before the Board. Main

OP is posted after 3 months.

10. OP No. 46/2016 Palod Muslim Samajam, Thiruvananthapuram

The petitioners had filed this petition under Sections 32, 69 and 70 of the Waqf Act,1995 seeking to frame a scheme for the administration of the Jama-ath and for other related reliefs. Evenafter service of notice the respondents failed to appear before the Board and they were set ex-parte. On the next posting the counsel for the petition submitted that he is not having any instruction from the petitioner and hence the matter was posted for orders. As the petitioner failed to appear before the Board and his counsel reported no instruction it is to be reasonably presumed that petitioners are not interested in prosecuting the matter further. Hence the OP is dismissed.

11. OP No. 10/2019 Kollam Pattalath Pally, kollam

The petitioners had filed this petition under Sections 32 and 70 of the Waqf Act,1995 seeking to pass orders for an overall enquiry about the use and authority of the Mayyavadi and the buildings therein at Makkani under the petitioner Jamaath and for other related reliefs. The respondents appeared and filed counter and the matter was posted for filing Chief Affidavit for substantiating the case. From 15/03/2023 the matter was posted for filing Chief Affidavit and even after affording several opportunity the petitioners failed to submit Chief Affidavit. On 11/07/2024 the counsel for the petition submitted that he is not having any instruction from the petitioner and hence the matter was posted for orders. As the petitioner failed to appear before the Board and his counsel reported no instruction it is to be reasonably presumed that petitioners are not interested in prosecuting the matter further. Hence the OP is dismissed.

 The petitioners had filed this petition under Sections 32, 46,47 and 48 of the

Waqf Act,1995 seeking to conduct audit of accounts of the Jama-ath from the year 2010 and for other related reliefs. While this matter was pending before the Board it is reported that the 1st petitioner is no more and the when the matter came up before the Board there was no representation from the side of the petitioner and the matter was posted for orders. It is to be reasonably presumed that the petitioners are not intending to prosecute the matter. But in this matter one of the prayer is auditing and board is duty bound to complete the audit process even if the petitioner is not interested. Hence, Divisional Waqf Officer, Thiruvanathapuram is directed to complete all procedure in connection with auditing including calling for objection, considering the same and give necessary directions for correcting the mistakes in maintaining accounts, ensuring that the account are maintained properly and place the matter before the Board through administrative side for recovering any amount that is certified by the auditor.

The main O.P is filed by petitioners under Sections 32, 47and 70 of the Waqf Act, 1995 seeking for a declaration that the election conducted in the Jama-ath is illegal, to conduct election to the Jama-ath committee, to conduct audit of accounts and for other related reliefs. While this matter was pending before the Board an interim order was passed by the Board on 31/05/2023 directing the Divisional Waqf Officer, Thiruvanathapuram to conduct audit of accounts of the JAma-ath for the period 2018-2023.

While the said matter was pending before the Board, the

petitioners in a connected OP bearing No.44/2024 had filed I.A.48/2024 seeking to frame a scheme for the election affairs of the 1st respondent as there is no registered bye-law of the jama-ath and I.A. 49/2024 for appointing a returning officer for conducting election to the jama-ath committee. The petitioners in the said OP had approached the Hon'ble High court of Kerala and the Hon'ble court was pleased to direct the Board to pass order in both the above I.A.s within a time frame. The Board in its meeting held on 11-07-2024 had heard both the matters together and decided to frame a scheme for the administration of the jama-ath under section 69 of the Wagf Act and draft scheme was framed by the Board and was published the same in the notice board of the Wagf as well as the notice board of the Board. On 05-09-2024 when the matter came up before the Board, the Board had considered the objections and had finalized the scheme as provided under section 69 of the Wagf Act, 1995 and the Board had appointed Adv. Muhammed Shafi, Ernakulam as the returning officer for conducting election to the jama-th committee through secret ballot system on the basis of the newly framed scheme. In such circumstances there is no point in proceeding this matter further as all most all the prayers are fulfilled. As auditing is already ordered by the Board the Divisional Waqf Officer, Thiruvanathapuram is directed to complete the audit process and call for explanation in the audit report and correct mistakes in the method of keeping accounts and if any amount is to be recovered from any person as provided in Section 47 of the Wagf Act the matter shall be placed before the Board through administrative side.

19. OP No. 102/2021 Nannathukav Pothencode muslim Jama-ath, Thiruvananthapuram

The OP is filed by the petitioners under sections 32 & 47 of the Waqf Act,1995 for conducting audit the income –expenditure accounts of 1st respondent Jama-ath from 2013 to till date and to collect the amount of loss incurred from those who are responsible for the alleged loss to the Waqf and subsequent disqualification from the administration of the Waqf.

Along with O.P the petitioners had filed **IA 127/23** seeking to audit the accounts of the Jama-ath during the period 2013 to March 31st 2015 and also the accounts for the period after April 2021 till the date of the petition. The I.A. was partially allowed directing the Divisional Waqf Officer TVM to conduct audit of accounts of the Jama-ath for the period from 2021 to 31-03-2024. The Board had earlier passed an order to audit the accounts of the Jama-ath from the

year 2015 and report is already received the petitioners had submitted objection to the audit report also. When this matter came up before the Board on 03/10/2024 the counsel for the respondents reported no instructions and hence the matter was posted for order.

Matters being so the the Board finds it just and proper to verify the audit report and take steps for correction of mistakes in keeping the accounts and to take steps to re-couping any amount that is certified by the Auditor as per the provisions of Waqf Act,1995. In such circumstances, the Divisional Waqf Officer, Thiruvanathapuram is directed to examine the audit report and take further steps for correcting the mistakes committed by the committee in keeping accounts in a scientific manner and to take steps to ensure that the mistakes are repeated by the committee. In taking such action the responsible persons as per the audit report may be heard by the Divisional Waqf Officer. If any amount is to be recovered from any person as per the certification made by the auditor as envisaged under Section 47 of the Waqf Act,1995 the Divisional Waqf Officer shall place the matter before the Board through administrative side.
