The petitioners filed this I.A. seeking appointment of an Interim Mutawalli to manage the affairs of the Jama-ath, contending that the term of the existing committee has expired and that the respondents are continuing in office without authority. The respondents appeared and submitted that the term of the committee has expired and that they are willing to conduct the election under the supervision of the Waqf Board.

On examination of the records, it is seen that the term of the existing committee has admittedly expired. Both parties have agreed to the fact that a new committee has to be constituted through election. Since the respondents have expressed their willingness to conduct the election under the supervision of the Board, appointment of an Interim Mutawalli at this stage is unnecessary, as it may only delay the election process and the smooth transition of administration.

Accordingly, the prayer for appointment of an Interim Mutawalli is **rejected**. Adv. **Sajal P.E.** is hereby **appointed as Returning Officer** to conduct the election to the Jama-ath Committee strictly in accordance with the approved bye-law and

under the supervision of the Board.

The Returning Officer shall issue election notification, ensure due notice to all eligible members, proper scrutiny of the voters' list, and transparent conduct of polling through secret ballot system. The election shall be completed within **two months** from the date of receipt of this order.

The Returning Officer shall be entitled to an **initial batta of** \square **25,000** \not , which shall be paid by the Jama-ath within **two weeks** from the date of receipt of this order. He shall also fix the **nomination fee not exceeding** \square **25,000** \not . The **expenses for the conduct of the election** shall be met from the **Jama-ath funds**.

The existing committee shall extend full cooperation to the Returning Officer and hand over all relevant records necessary for the smooth conduct of the election.

6. OP No. 128/2023 Kappukad Muslim Jama-ath, Thiruvananthapuram Order passed vide separate sheet in IA No. 421/2025. Posted to 04.12.2025

IA No. 421/2024

The petitioners in I.A. No.421/2024 in O.P. No.128/2023 have requested permission to conduct the election to the Kappukad Muslim Jama-ath Committee as per the approved bye-law, stating that the term of the existing committee, elected on 20.01.2023, will expire on 20.01.2025. The Jama-ath is a registered waqf functioning under the supervision of the Kerala State Waqf Board, and its affairs are being managed in accordance with the approved bye-law. The existing committee was constituted in compliance with the said bye-law, and as per its relevant provisions, the term of office of the committee is two years. Hence, the next election is due on 20.01.2025.

The respondents have filed a counter admitting that the term of the committee, as per the bye-law, is two years. Their objections are mainly with respect to certain ancillary issues raised in the connected petition and not related to the conduct of the election. Therefore, there is no dispute or legal impediment regarding the necessity of conducting the election in time.

Since the conduct of election is mandated by the bye-law and the continuity of management is essential for the proper administration of the Jama-ath, the Board is of the view that necessary steps are to be taken immediately for conducting the election in a fair and transparent manner. Accordingly, the Board appoints Adv. Ismail Adam Sait as Returning Officer to conduct the election to the Kappukad Muslim Jama-ath Committee in accordance with the approved bye-law and through the secret ballot system. The Returning Officer shall ensure due notice to all eligible members, proper scrutiny and finalisation of the voters' list, transparent conduct of polling, and submission of the election report to the

Board for confirmation immediately after the election.

Since the election is being conducted under the direct supervision of the Returning Officer, there is no necessity to appoint a separate observer. The Returning Officer shall be entitled to an initial batta of \Box 25,000 \angle , which shall be paid within two weeks from the date of receipt of this order. The Returning Officer shall fix the nomination fee not exceeding \Box 25,000 \angle and conduct the election strictly in accordance with the provisions of the bye-law after following all procedural formalities and ensuring fairness in the process. The expenses for the conduct of the election shall be met from the Jama-ath funds.

IA No. 377/2024

The petitioner in this I.A. has requested the Board to initiate prosecution proceedings against the respondents, alleging that they have demolished the Khabaristan of one of the founders of the Kappukad Jama-ath and commenced unauthorised construction in the said waqf property, in violation of the interim directions of the Board which restrained them from taking any policy decisions regarding the Jama-ath.

The respondents appeared and filed a counter denying the allegations. They contended that they are the duly elected office bearers of the Jama-ath Committee elected in January 2023, functioning as per the approved bye-law, and that the work undertaken was only for protection of the waqf property and not for any unauthorised construction. They further stated that there was no violation of the Board's order or any financial irregularity.

In view of the rival contentions, the Board directs the Divisional Waqf Officer concerned to conduct a detailed site inspection and submit a report before the Board after verifying the present position of the property. The officer shall also collect and produce the minutes of the meeting in which the decision for the construction or renovation was taken, and specifically report whether any act warranting prosecution under the Waqf Act has occurred.

Till submission of the report and further orders of the Board, no further construction, alteration, or modification shall be made in the disputed Khabaristan area.

7. OP No. 14/2022 Manakkad Valiya Pally Muslim Jama-ath, Thiruvananthapuram

The present Original Petition is filed under Sections 32 and 70 of the Waqf Act, 1995, seeking directions to the respondents to convert the petitioner's temporary membership into permanent membership in the 1st respondent Jama-ath, and to grant him all rights, including voting rights, in accordance with the bye-law of the Jama-ath.

The petitioner contends that he has been a resident within the jurisdiction of the 1st respondent Jama-ath for more than sixty years and has been a member participating in all religious and social activities of the Jama-ath. It is alleged that while several persons who are similarly situated were granted permanent membership with voting rights, he was arbitrarily denied such status without any valid reason. The petitioner asserts that there are no restrictions or criteria in the bye-law disqualifying him from permanent membership and that the denial is discriminatory and contrary to the principles of natural justice.

The respondents filed a written statement denying the allegations and contended that only permanent members are entitled to voting rights. It was stated that persons residing within the boundaries of the waqf may be granted membership after consideration, but the

previous committee's actions in granting permanent membership to certain individuals are under enquiry. It was further submitted that the petitioner was not denied any benefits or services from the Jama-ath other than the right to vote.

On perusal of the records, it is evident that the petitioner has been a long-standing resident within the jurisdiction of the Jama-ath and has been availing all religious and community services like other members. There are no valid reasons or prohibitions under the bye-law to deny permanent membership to him. The differential treatment, especially when similarly placed individuals have been granted permanent membership, is arbitrary and unsustainable.

Accordingly, the petition is **allowed**. The respondents are directed to grant **permanent membership** to the petitioner in the 1st respondent Jama-ath, with all rights, privileges, and obligations available to other permanent members, including voting rights.

The petitioner shall pay all dues, subscriptions, and other amounts payable by permanent members of the Jama-ath. Both the petitioner and the respondents are directed to cooperate with each other and function harmoniously for the smooth administration and unity of the Jama-ath.

8. OP No.62/2023 Karalikkonam Karakkal Muslim Jama-ath, Kollam Order passed vide separate sheet in IA No. 312/2024. Posted to 04.12.2025

The Board has considered I.A. No.312/2024 filed in O.P. No. 62/2023, wherein the petitioners seek to amend the Original Petition to (i) add contentions concerning rules for construction in waqf property, (ii) incorporate particulars of a stay order and complaint before the Divisional Waqf Officer, and (iii) include a prayer for a declaration that the tender dated 25.01.2023 violates the Kerala Waqf Rules.

On perusal of the records it is evident that the competent officer of the Board has already granted permission for the construction after due verification. The proposed amendments to incorporate facts relating to such permission are therefore redundant. Further, the additional prayer for a declaratory relief does not lie within the jurisdictional scope of the Board while exercising powers under Section 32 of the Waqf Act, 1995. Granting the amendment would only introduce matters beyond the Board's competence and would cause unnecessary expansion of issues at this stage.

For these reasons, the amendment application is devoid of merit and is liable to be rejected. Accordingly, **I.A. No.312/2024 is dismissed.** The Original Petition shall proceed on the basis of the existing pleadings.

12. IA No. 375/2024 in OP No. 130/2022 Kuramapuram Muslim Jamaath, Thiruvananthapuram

The present interlocutory application is filed by the petitioner seeking to set aside the ex parte order passed against him in the Original Petition, and to restore the case to file for fresh consideration after affording him an opportunity to present his contentions.

The petitioner contended that he had not received any notice in connection with the proceedings and became aware of the matter only upon receipt of a communication from the Divisional Waqf Officer dated 23.10.2024, referring to the audit report.

The respondent filed a counter denying the petitioner's contentions and submitted that the plea of lack of notice is false, pointing out that the petitioner had earlier filed O.P. (Waqf) No.31/2022 before the Hon'ble High Court of Kerala. It is also contended that the petitioner has not filed any petition for condonation of delay and that the present I.A. is liable to be dismissed on that ground alone.

On consideration, this Board finds that although there has been considerable delay in filing the present petition, the ends of justice would be better served by granting the petitioner one final opportunity to contest the matter on merits, subject to payment of reasonable cost.

Accordingly, the petition is **allowed** on condition that the petitioner shall pay a sum of \Box 5,000/ (Rupees Five Thousand only) as cost to the respondent within 15 days from the date of receipt of this order. On such payment, the ex parte order shall stand **set aside**, and the case shall be **restored to file** for fresh disposal after hearing both sides.

In case of default in payment within the stipulated period, this order shall stand automatically **vacated** and the ex parte order shall continue to remain in force. Posted to 04.12.2025

16. OP No. 218/2024 Valiya Veli Kanjirod Puthen Pally Jama-ath, Thiruvananthapuram .

Order passed vide separate sheet.

The present Original Petition is filed under Section 32 of the Waqf Act, 1995, seeking to cancel the decision of the general body of the first respondent Jama-ath dated 25.08.2024 and for consequential reliefs restraining the respondents from carrying out any construction in the waqf property without permission from the Waqf Board and competent local authorities.

The pleadings and materials on record show that the Divisional Waqf Officer, by order dated 06.01.2025, had already granted permission for the reconstruction of the mosque after due verification and compliance with statutory requirements. The respondents have also produced documents showing that necessary local authority permissions were obtained and that construction has since been completed. Hence, the relief sought in respect of construction has become infructuous.

As regards the grievance of the petitioners concerning their alleged expulsion and denial of Jama-ath membership benefits, the materials do not establish that any valid order of expulsion was passed following due procedure prescribed under the bye-law. The Board considers that, being members of the Jama-ath, the petitioners are entitled to all religious and community services extended to other members.

Accordingly, it is ordered that—

- 1. The first respondent Jama-ath Committee shall ensure that the petitioners are provided all religious and community services and privileges extended to the members of the Jama-ath without any discrimination.
- 2. The petitioners shall pay all dues and contributions payable by members for availing such services, including any amounts regularly collected by the Jama-ath.
- 3. The petitioners shall co-operate with the Jama-ath and its committee in maintaining peace, harmony, and unity among the members and shall refrain from any activity likely to cause division or disturbance in the Jama-ath.

With these directions, the Original Petition is disposed of.

17. OP No. 242/2024 Kaniyapuram Muslim Jama-ath, Thiruvananthapuram.

Order passed vide separate sheet.

The petitioner, Mr. Naseer, filed the present Original Petition challenging the decision of the Kanaiyapuram Muslim Jama-ath Committee (3720/RA) dated 01.11.2024, whereby his membership in the Jama-ath was cancelled. The petitioner, as directed by the Jama-ath Committee, had obtained a release certificate from his previous Jama-ath and paid a sum of Rs. 1,00,000/- as contribution demanded by the Committee. Consequently, membership was granted to him and his family in the Kanaiyapuram Muslim Jama-ath. However, in the meeting held on 01.11.2024, the Committee resolved, by a majority, to cancel the membership of the petitioner alone, and a letter to that effect was issued to him on 08.11.2024. Aggrieved by the said decision, the petitioner approached this Board seeking a stay of the Committee's action, and by interim order dated 20.11.2024, this Board stayed

the operation of the impugned decision.

Respondents 1, 2, 4, and 5 filed a counter supporting the petitioner, contending that the term of the Committee had expired on 11.08.2024 and that the meeting held on 01.11.2024 was convened by a caretaker committee having no authority to take such a decision. It was further contended that the petitioner's membership was cancelled without affording him an opportunity of being heard, thereby violating the principles of natural justice and the provisions of Sections 14(1), 14(4), and 14(5) of the registered bye-laws of the Jama-ath. Respondent No. 3, on the other hand, filed a counter denying the allegations and stated that due to limited resources and inadequate space in the graveyard, it was difficult to admit new members. It was further submitted that Respondents 1, 2, 4, and 5 fraudulently recorded in the minutes that membership had been granted to the petitioner and that the Committee, upon discovering the manipulation, decided to cancel the petitioner's membership and refund the amount received from him.

Respondent No. 3 filed I.A. No. 123/2025 challenging the maintainability of the Original Petition before this Board, relying upon the judgment reported as 2025 KHC Online 64, contending that the dispute is beyond the jurisdiction of the Waqf Board. However, Respondents 1, 2, 4, and 5 filed a counter stating that the cited judgment pertains to registration of Waqfs, whereas the present dispute concerns the internal management of a registered Jama-ath, which falls within the jurisdiction of the Waqf Board. Respondent No. 3 also filed I.A. No. 239/2025 seeking the appointment of a Returning Officer to conduct the election of the Committee. The relief sought in that I.A., however, is distinct from the subject matter of the Original Petition, which relates only to the cancellation of the petitioner's membership.

Though the matter was posted for orders on the question of maintainability, the Board finds that the petition is maintainable. The objection as to maintainability is based on the decision of the Hon'ble High Court of Kerala in the matter of *Panachikkappalli Jama-ath*, which was subsequently modified by the Hon'ble Court itself. The disputes relating to membership, internal management, or violation of natural justice in registered Waqf institutions fall squarely within the supervisory jurisdiction of the Waqf Board under Sections 32, 33, and 67 of the Waqf Act, 1995. Therefore, the Board is of the view that the present petition is maintainable.

While considering the issue, the Board observes that the removal of a person from membership of a Jama-ath has serious implications on his religious and human rights. Such action not only affects the right to participate in religious and communal functions but also deprives him of recognition as a member of the Muslim community attached to that Jama-ath. The Board has already issued a circular to all Mahal Committees directing that no person shall be expelled or excluded from Jama-ath membership without prior notice, opportunity of hearing, and compliance with the bye-laws.

On an evaluation of the records, it is evident that the meeting held on 01.11.2024 was convened by a caretaker committee after the expiry of its term and, therefore, lacked lawful authority. The decision to cancel the petitioner's membership was made without affording him a reasonable opportunity to be heard, thereby violating the principles of natural justice. Further, the allegation of manipulation of minutes has not been substantiated by any credible evidence. Hence, the decision of the Kanaiyapuram Muslim Jama-ath Committee dated 01.11.2024 cancelling the petitioner's membership cannot be sustained in law.

In the result, O.P. No. 242/2024 is allowed dismissing I.A. Nos. 123/2025 and 239/2025. The decision of the Kanaiyapuram Muslim Jama-ath Committee dated 01.11.2024

	cancelling the membership of the petitioner is hereby set aside. The interim stay granted on 20.11.2024 is made absolute. The Committee shall act strictly in accordance with the byelaws.

The present Original Petition is filed by the petitioner seeking to cancel Exhibit 3 decision of the Jama-ath Committee, contending that the said decision is illegal, arbitrary, and contrary to the provisions of the approved bye-law of the Jama-ath. The petitioner has further sought directions to conduct the election to the Jama-ath as per the bye-law, to audit the accounts of the Jama-ath for the period from 2018 to 2024, and for other connected reliefs.

It is seen from the records that the prayers relating to the conduct of election and audit of accounts (prayer Nos. 2 and 3) have already been considered and allowed by this Board. A Returning Officer was appointed by the Board, who has conducted the election and submitted his report. Regarding the audit of accounts, it is ordered that the audit report shall be verified by the Divisional Waqf Officer, Thiruvananthapuram. If, on such verification, any amount is found to be recouped or recovered from any person, the matter shall be placed before the Board through the administrative side by the Divisional Waqf Officer. In case any defect or irregularity is noticed, the Divisional Waqf Officer may issue appropriate directions to cure the same and seek necessary explanations from the concerned persons.

The only remaining issue in this Original Petition is with respect to Exhibit 3, by which the petitioner and his family were removed from the primary membership of the Jama-ath. The petitioner has specifically contended that the said decision was taken without any general body resolution and without issuing a show-cause notice or affording him an opportunity to be heard.

On a careful perusal of the available records and the submissions of both sides, this Board finds that the impugned decision contained in Exhibit 3 was taken in clear violation of the principles of natural justice, as no notice or opportunity of explanation was provided to the petitioner prior to the expulsion. Further, the decision to expel a member or family from the Jama-ath directly affects their religious rights, including their right to participate in mosque prayers, burial in the kabaristan, and other religious and community activities associated with the Jama-ath. Such decisions, when taken arbitrarily, have been consistently held by the Hon'ble High Court of Kerala to be illegal, unconstitutional, and violative of the fundamental and

religious rights of individuals.

The Kerala State Waqf Board has, in its circulars issued to all Mahal and Jama-ath Committees, clearly directed that no member shall be expelled or excluded from the Jama-ath without following the due procedure prescribed in the bye-law and without prior approval of the Board. The Board has also cautioned that any such actions will amount to interference with the religious and human rights guaranteed to members of the Muslim community.

The Board is, therefore, of the considered view that Exhibit 3 decision removing the petitioner and his family from the primary membership of the Jama-ath is illegal, arbitrary, and unsustainable in law. Expulsion from Jama-ath membership cannot be used as a punitive tool to settle internal disputes or personal differences. All members of the Jama-ath are entitled to equal rights in the usage of the mosque, kabaristan, and participation in religious functions, subject only to compliance with the approved bye-law and general discipline of the institution.

Accordingly, Exhibit 3 order of the Jama-ath Committee cancelling the membership of the petitioner and his family is hereby set aside. The membership of the petitioner and his family in the Jama-ath stands restored with immediate effect. The Jama-ath Committee is directed to provide all religious and community services to the petitioner and his family on par with other members of the Jama-ath.

It is further ordered that the Jama-ath Committee shall not, in future, take any decision affecting the membership or religious rights of any individual without following due process of law and prior approval of the Board. Any violation of this order shall invite prosecution proceedings against the committee and its responsible members under the provisions of the Waqf Act, 1995.
